COLLECTION AND USE OF INFORMATION

This may include information relating to your identity, contact details, employment, income, liabilities, assets, and any other relevant financial information. Failure to provide this information may impact our ability to assist you.

DISCLOSURE OF INFORMATION

Your personal information may be disclosed to LMG Broker Services Pty Ltd, credit reporting bodies (CRBs), credit providers, insurers, platform providers, professional advisers, government bodies and other third parties where required or permitted by law.

DATA SECURITY

We take all reasonable steps to protect your personal information from misuse, interference, loss, or unauthorised access. Information is held securely, and access is limited to authorised personnel.

When information is no longer required, we take reasonable steps to destroy or de-identify it.

YOUR RIGHTS

You may request access to the personal information we hold about you, request corrections if the information is inaccurate, and request a copy of this policy in a suitable format. You may also request CRBs not to use your data for direct marketing or pre-screening and to restrict disclosure where fraud is suspected.
